4.0 Legislative Proposal

Tateishi indicated that he had met with Congressman Norman Mineta to seek his recommendations. It was suggested by Congressman Mineta that a delegation of JACL individuals meet with the Nikkei members of Congress to further discuss the REDRESS legislative proposal. Non-Nikkei members of Congress were also suggested.

The necessity of proper media coordination was discussed, as was the need for additional monies to further the progress of the National REDRESS Program. Chairman Tateishi indicated that Ms. Karen Seriguchi has offered her assistance in seeking funds through available grants.

5.0 Presentation of the National Education Campaign on the vulnerability of the American Bill of Rights - Nobuyuki.

Discussion outlined the general concept of the violation of the Constitutional rights of individuals. The need for position papers to be submitted with any legislative proposal and additional monies that would be necessary to properly educate and synthesize all material was also discussed in length. It was agreed that Staff would work with Ms. Seriguchi to assist in the development of a proposal for foundation funding.

6.0 Presentation of the IRS Check-Off Plan - Mamiya (See Attachment #1)

Mamiya discussed the need to establish a per diem amount based on property loss, income/business/personal losses to calculate and further clarify the \$25,000 issue. The IRS method was designed to avoid a direct appropriations approach and thereby make it easier for Japanese Americans to receive financial compensation.

7.0 Presentation of the Constitutional Endowment Fund Plan - Nobuyuki

Nobuyuki presented a plan modeled after the U.S. - Japan Friendship Act Trust Fund that would establish a perpetual fund by direct appropriation for consideration. Interest from the fund would be used to pay individuals and develop community projects. A variation of the plan was

Move that the proposed bill shall include: (1) Repeal of the legal basis of the Japanese American cases and a declaration against the effects of the evacuation cases; & (2) Recognition by Congress of the loyalty of Japanese Americans in a statement that will be part of the legislation.
