
1. By order heretofore issued by the Commanding General, Western Defense Command, you were prohibited from being in, remaining in or entering the West Coast Exclusion Zone, the Coastal Exclusion Area of the Eastern Defense Command and the exclusion area of the Southern Defense Command, all said areas being more particularly described in said order, to which reference is hereby made.

2. You are hereby notified that that portion of the above-described order issued by the Commanding General, Western Defense Command, which prohibited you from being in, remaining in or entering the defined and designated exclusion areas of the Eastern Defense Command and the Southern Defense Command, is hereby rescinded.

3. This modification of your order shall have no effect upon the remaining provisions thereof, excluding you from the West Coast Exclusion Zone, which said prohibition shall continue in force until revoked by competent authority.

4. For your information the area designated in your exclusion order as the West Coast Exclusion Zone is officially delineated in Civilian Restrictive Order No. 32, dated 15 December 1944, which includes generally the western half of the State of Washington, the western half of the State of Oregon, all of the State of California and the southern one-third of the State of Arizona.

SUPPLEMENT TO INDIVIDUAL EXCLUSION ORDER


For your information the area designated in your exclusion order as the WEST COAST EXCLUSION ZONE is officially delineated in Civilian Restrictive Order No. 32, dated 15 December 1944, which includes generally the western half of the State of Washington, the western half of the State of Oregon, all of the State of California, and the southern one-third of the State of Arizona.

You are also excluded from the COASTAL EXCLUSION AREA of the Eastern Defense Command as defined and designated by the Commanding General, Eastern Defense Command, Governors Island, New York, New York. This coastal exclusion zone includes generally all those counties which border on the Atlantic Ocean.

You are also excluded from the exclusion area as prescribed by the Commanding General, Southern Defense Command, Fort Sam Houston, Texas. This area includes generally those counties bordering on the Gulf of Mexico and the Mexican border and the southeast one-third of the State of Louisiana as defined and designated by Public Proclamation No. 1, dated 30 May 1942, issued by the Commanding General, Southern Defense Command.

The above exclusion areas are subject to change as may be ordered by appropriate military commanders. You will be informed when such changes are made.
