DIARY OF EVACUATION OF JAPANESE ANCESTRY CITIZENS AND ENEMY ALIENS, 1942 (James Kado kept a diary in three* "Spiral" note books)

We arrive in Pomona Assemby Center on April 10, 1942, from Hollywood Presbyterian Church, by escort of M.P.Guards. We all were in State of History & Mind. We just don't know what we all were doing at this time.

The camp conditions were bad. During mess hours we have to stand in line for hours before we get to eat. Most every one of us were sick on account of different food and not of use to the camp living. The food was very bad at first.

I start to work when things settle down. The wage were eight dollars month for start. We got spending coupon for buy some small articles at canteen.

\$2.50 were coupon who working one month.

Beginning of August we went to get clothing allowance but we all did not get the allowance.

They were rumors that we are to be move to Wyoming or Poston, Arizona.

For about past two months we have curfew hour in cam. We all must sleep at 9.00 and police come and wake us up for head count at 11:30 or 12:00 at night.

The first leave for Wyoming known. They left 11th of August. All Mess 2 volunteer for first group.

We all were unease because we have to pack our belonging and have police to check the freight and baggage.

We heard that at Santa Anita Center the police inspect evacuees good and stole lot of valuable things. It was cheap way to do such things. They were caught later.

We left Pomona Assembly Center at 18 of August, and we arrive at our destination of Wyoming Relocation Concentration Camp at 23rd.

Boy we sure were tired. All sleep on hard seat sitting. This was my first long trip on train. It was lonesome trip.

The food were fine on train. It was first real good meal since we left home.

The day we reach here were fine day, but next day was so dusty and inside that I thought was hell.

*These 9 pages typed from James Kado's note books We felt more ease now than we were first put in Pomona.

Two days later I started to work in mess (hall). The mess conditions were much better than Pomona. I was glad.

September 18, 1942.

We saw first snow since we got here. The kids were glad.

People around start to clean place and hard.

It is October now and it getting to be little cold.

We all afraid of cold weather.

The ceiling and side are not celotex yet.

Volunteer and worked to put up ceiling and side. It is much warmer now.

First Thanksgiving were spend at camp. We all had turkey Boy it was good.

Christmas arrive. We did not worried much for last minute shopping.

We had nice Christmas Each had present from outside Christian Church and clubs. We all appreciated their kindness.

January getting to be real cold.

On 18th the temp. went down to 30 degree below zero. Boy it was sure cold.

All enjoy skating on ice.

There are two canteen. 1 Dept. Store.

SECOND DIARY OF JAMES KADO

True that all the Japanese Ancestry have been evacuated by Military order which I did not contested the problem then but I complied with U.S. Army order and proclamation by the President of United States on the basis of Loyalty but was evacuated against my will. My right as citizen and the mass representation which I (illegible phrase here).

Lincoln Proclamation was for the emancipation a man's rights but proclamation of evacuation was against the right of individual and citizens.
